Asymmetric Members Group (AMG) REQUIREMENTS

1. Meets application criteria per AMG application requirements set forth
2. Must possess High School Diploma or GED equivalent
3. Must pass background check criteria
4. Has the Ability to Carry 25lbs for 100yds (Equivalent weight to Weapon, multiple magazines, and body armor)
5. Must memorize and recite Weapons Safety Rules upon acceptance into AMG

I WILL...

- a. **TREAT** every weapon as if it is loaded even after ensuring it to be unloaded
 - b. **NEVER** point the weapon at anything I do not wish to shoot
 - c. **KEEP** my weapon on safe until I intend to fire
 - d. **KEEP** my finger straight and off the trigger until I intend to fire
 - e. **KNOW** my target and consider its foreground and background
6. Upon acceptance must recite and sign AMG pledge:

Questions and Answers:

All members will be billed the set AMG fee of \$175.00 per month. Payment is due on the 1st of each month. Delinquent memberships are subject to non-refundable cancellation after 15 days. Reinstatement will require returning to the AMG waiting list for an opportunity for a slot to open.

1. I do not know an AMG member that could sponsor me. What, if any, requirements would need to be met to become a member without a sponsor?

A. Any person that does not currently have a sponsor for the AMG can reach out to the corporate office for detailed sponsorship opportunities. All AS staff will screen initial AMG applications to establish a baseline of AMG members (July 1- Aug 31) for future sponsorships.

2. Is the 90-day review period the same without a sponsor referring me?

A. Yes

3. What does a weapons safety manipulations test consist of?

A. This test consists of demonstrating the safe handling and manipulation of a sidearm during:

- Loading of the weapon
- Holstering of the weapon
- Drawing the weapon from the holster
- Presenting and firing the weapon
- Transition from firing the weapon to the low or high ready
- Reloading the weapon
- Re-holstering the weapon

4. Will my acceptance letter provide me with a tentative 90-day review period before I become a full member?

A. You will be considered a member of the AMG upon acceptance. The 90-day review period is when there is an observation of the adherence to the rules and guidelines outlined in the AMG application package.
